There is much more to sponsoring someone than most people realize. This is very important!

THE AIM OF SPONSORSHIP

Every youth who attends Chrysalis has a "sponsor" who supports and encourages him/her before, during, and after the Chrysalis experience.

Sponsorship is the way in which the Chrysalis experience is passed on from person to person, reflecting the manner in which God purposefully reaches out to people through other people. After a Chrysalis Weekend, you may want to share the gift of those three days with others. Sponsorship provides you with a caring and disciplined way to share. And in doing so, you, the sponsor, participate in and demonstrate God's outreaching love.

Sponsorship is taken for granted in many communities. The assumption is that everyone knows the how and why of sponsorship. Sometimes sponsorship is only discussed with reference to the number of participants signed up for a Chrysalis Weekend.

Make no mistake. **Sponsorship is the most important job in the Chrysalis Movement**. It is a job shared by the adults who have been through Emmaus and the youth who have been through Chrysalis and Journeys. It is more than simply "signing youth up." The importance of a Chrysalis Community being educated about good sponsorship cannot be overemphasized. The quality of sponsorship impacts the new participants, the health and effectiveness of the Chrysalis Movement, and the churches being affected by Chrysalis.

The aim of sponsorship is the same as the aim of Chrysalis: the spiritual growth of young Christians as disciples of Jesus Christ through **churches** and **their youth groups**. Every sponsor should reflect upon his or her motivation for wanting to sponsor another youth and make sure it is consistent with this aim.

Reasons NOT to sponsor someone are:

- "to get all of my friends to go"
- * to fix a young person's problems or crisis
- * to have a full weekend
- * to reproduce one's own religious experience in others

Sponsorship can be motivated, however, by a number of hopes and prayers for youth which are consistent with the aim of Chrysalis. These include giving youth the gift of three days apart:

- to experience the accepting and healing grace of God through Christian community
- * to realize they are precious in God's eyes, that they are here on this earth for a holy purpose
- * to discuss without judgment their questions and struggles as young persons with peers and mature Christian adults
- * to hear anew the gospel of God's love in Jesus Christ and the basics of Christian faith and life
- to make friends with other youth who share the faith and will support each other in living as Christians
- to develop relationships with mature Christian adults, relationships which might extend beyond the three days
- * to be strengthened in their decisions to follow Jesus
- * to be better prepared to live as Christian witnesses in home, school, church, and community
- * to learn what goes into building their lives and relationships on a solid foundation
- * to bring new vitality to the church youth group upon returning, to inspire the sponsorship of other youth, to energize the body of Christ through young people whose hearts are on fire with the love of Christ.



Sponsor Responsibilities

Listed on the application are the following items you must agree to and follow through with to sponsor a Caterpillar for Mountain Top Chrysalis. **Sponsorship is a great responsibility.**

- **1. Registration:** You must bring your candidate to registration between 8:15 8:45 AM. (If you can't bring them because you are on the team, please designate another community member to do this).
 - **2. Sponsor's Hour:** You must attend sponsor's hour. If you can't, please designate someone who can attend in your place and pray for your candidate!
 - **3. Candlelight:** You must attend candlelight. If you can't, please designate someone who can attend in your place and pray for your candidate!
 - **4. Closing:** You must attend closing parents are welcome!
 - 5. Agape Letters: You need to make every attempt possible to get a minimum of 12 letters for your caterpillar.
 - 6. You are to have minimal contact with your candidate during the flight, so they can fully experience the week end.

Other Items Recommended for the Sponsor:

- 7. **Prayer Vigil:** Your caterpillar will be looking for your name on the Prayer Vigil, so please go to our website to sign up for a time slot.
- **8. Agape Gifts / Food:** The conference room can never have enough Agape. If you would like to make some, we ask that you provide 60 of each agape gift.
- 9. Serving in the Dining Room, Kitchen, or Prayer Chapel.

Application: Please make every attempt to submit your application <u>at least 7 days</u> in advance. **YOU MUST** contact the registrar listed on the application if you are filling out an application within seven days of the flight.

Please let your caterpillar know the following information about the weekend:

- They will want to bring basic bedding (sleeping bag or sheets, blanket, and pillow), towels, comfortable clothing
 (dress is casual for the weekend), a jacket just in case the conference room gets cold, dress clothes for a special
 dinner, and toiletries. Everything else they need will be provided. (Remember your flight or walk...)
- No cell phones, iPods, or other electronic devices. Make sure that they tell their friends that they will be unavailable for the weekend. We want them to relax and forget about the outside world for a few days.
- If they need to take scheduled medications, there will be adults in the conference room that will remind them.
- We need to know as the time of application if there are any special dietary requirements. This is essential, so we can shop appropriately.
